## ***Multiplicity of Other*. Nuove ricerche e approcci critici intorno a forme altre dell'abitare**

### Abstract

*Multiplicity of Other* è il titolo della ricerca presentata dal Padiglione Olandese alla 17° Biennale di Architettura di Venezia, intitolata *How we will live together*.

Afaina de Jong, curatrice del padiglione, introduce la “molteplicità dell'altro” come una nuova strategia progettuale che - attraverso lo studio di spazi liberi in cui voci diverse e solitamente inascoltate si possano esprimere - sfidi il paradigma architettonico dominante.

I tre giovani ricercatori invitati a questo seminario stanno conducendo ricerche anche apparentemente lontane, sviluppate tutte a livello internazionale, che condividono un simile approccio critico: fare di forme altre dell'abitare - i luoghi di vita istituzionalizzati, di cura, di educazione, di detenzione, i luoghi di vita progettati per e con le persone *neuroatipiche* - campi in cui sollevare una riflessione sui paradigmi consolidati del progetto architettonico e sul loro possibile ripensamento, rinnovamento, sovvertimento.

#### **Francesco Zuddas**

works as an architect, teacher and researcher in architecture and urbanism, and is co-founder of urbanaarchitettura with Sabrina Puddu. He studied architecture and urbanism at the University of Cagliari and the Architectural Association, receiving an MSc, an MA and a PhD.

Since 2009 he has taught architectural design studios and delivered history and theory seminars and lectures at the University of Cagliari, Leeds Beckett University, Central Saint Martins, and the Architectural Association. He is frequently an invited critic at schools of architecture and juror in international architectural competitions. At the ARU School of Architecture he is module leader for second year BA Architectural Design, and lectures in the history and theory of architecture.

Francesco's research sits on the edge of the discourses of architecture and urbanism, with a specific interest in understanding the city through the project of some of its major public institutions. He has received postgraduate studies scholarships and research fellowships from the European Union/Regional Government of Sardinia, including a two-year grant for the project “The Architecture of Innovation” (2010-12). In 2013-14 he was Visiting Research Scholar at GSAPP, Columbia University. He has co-authored two books and publishes regularly on architectural journals and magazines. His current research is an investigation of the space of the university as a paradigm for understanding the modern city, and he is working on a book from his doctoral dissertation *The University as Settlement Principle. The Territorialisation of Knowledge in 1970s Italy*, a study of large-scale projects for higher education around 1968.
