

General remarks

CAPITAL of S.P.A.



e.g. The capital stock amounts to EURO 29,045,044.98 (twentyninemillionfortyfivethousand fortyfour point ninetyeight) and is divided into 484,084,083, common shares stock of nominal value, EURO 0.06 (zero point zero six euro) each (Luxottica Group s.p.a.)

- Memorandum of incorporation
 - (nominal) value expressed
 - (nominal) value not expressed

SHARES AND CAPITAL

• Indivisible, homogeneous, standardised, freely transferable

- Certificate/dematerialization
- Rights granted
 - Administrative
 - Proprietary
 - Mixed
- Indipendent from the number
- Dependent on the percentage
- Proportion to the number of shares

- EQUALITY PRINCIPLE

 - Increased voting shares and multiple voting shares
 - Shares with voting right on specific matters or upon the occurrence of certain events or without voting right
 - Preferred shares
 - Tracking shares

 - Shares in favour of employees

 - Deferred shares

- Circulation
 - Freely transferable
 - Limits:
 - Legal vs by-laws
 - Shareholders' agreements
 - Pre-emption clause
 - Approval clause
 - Acquisition of its own shares

DEBENTURES

Increasing corporate capital VS debt

- They don't represent a portion of the corporate capital
- They don't entitle their holders to dividends
- The principal amount has to be repaid
