If I had maintained the initial criteria, only 3 people would have passed the exam. In the near future I will post the twenty proposed questions on the "Virtual Notice Board" so that it is possible for everyone to understand the level of difficulty that needed to be addressed. People

who passed the exam with 18/30 should know that in assigning such a mark I simply acknowledge the futility of asking them to demonstrate even a remotely serious level of preparation. I consider it a defeat of my idea of a university.

For those who failed the exam - especially if this was the umpteenth test they were 'attempting' - let me suggest one thing: perhaps it is time to stop complaining about an alleged complexity of the exam (which does not exist) and that they start studying this subject seriously (from scratch).
